INCREASE IN AUTHORISED CAPITAL

"RESOLVED THAT pursuant to the provisions of section 94(1)(a) of the Companies Act, 1956, the Authorized Share Capital of the Company be and is hereby increased from Rs.184,00,000/- (Rupees One hundred eighty four lacs) divided into 18,40,000 Equity Shares of Rs.10/- each to Rs. 260,00,000/- (Rupees Two crores sixty lacs) divided into 26,00,000 Equity Shares of Rs.10/- each by creation of further 7,60,000 Equity Shares of Rs 10/- each ranking pari passu with the existing Equity Shares of the Company and accordingly Clause No. 'V' of the Memorandum of Association be substituted by the following Clause: -

'V' The Authorized Share Capital of the Company is 260,00,000/- (Rupees Two crores sixty lacs) divided into 26,00,000 Equity Shares of Rs 10/- (Rupees Ten) each with such rights, privileges and conditions attaching thereto as are provided by the regulations of the Company for the time being, with power to increase and decrease the capital of the Company and to divide the shares in capital for the time being into several classes and to attach thereto respectively such preferential rights, privileges or conditions as may be determined by or in accordance with the Articles of the Company for the time being and to modify or abrogate any such rights, privileges or conditions in such manner as may be permitted by the Act or provided by the Articles of the Company for the time being.

1. A member entitled to attend and vote at the meeting is entitled to appoint a proxy to attend and vote instead of himself. The proxy need not be a member of the Company.
2. An instrument appointing a proxy, in order to be effective must be received by the Company at its Registered Office at least 48 hours before the commencement of the meeting.
3. The Register of Members and Share Transfer Register of the company will remain closed from 18th day of August, 2010 to 25th day of August, 2011 (both days inclusive)
4. An Explanatory Statement pursuant to Section 173(2) of the Companies Act 1956 is annexed hereto

EXPLANATORY STATEMENT
(Pursuant to Section 173(2) of the Companies Act, 1956)

The present Authorized Share Capital of the Company is Rs. 184,00,000/- (Rupees One eighty four Lacs only) divided into 18,40,000 Equity Shares of Rs. 10/- each. Pursuant to the scheme of amalgamation of M/s Simon Vanijya Pvt. Ltd and M/s Swagath Vanijya Pvt. Ltd with the company as approved by the Hon'ble High Court, Kolkata vide order dated 11.07.2011, the company is required to issue and allot shares to the shareholders of the above Transferor Companies in the ratio of 7(seven) Equity shares of Rs10/-each credited as fully paid up in the books of the Transferee company for every 1(one) equity share of Rs10/-each fully paid up and held by shareholder in the Transferor companies. Accordingly it is desirable to increase the present authorized share capital of the company to enable fresh issue of equity shares in terms of scheme of amalgamation.

Hence, it is desirable to increase the authorized share capital of the company from its present standing as stated in the resolution to meet the obligation of the shareholders and also substitute the provisions as regards the authorized share capital contained in the Memorandum and Articles of the company.

The consent of shareholders is required as per provisions of the Companies Act, 1956. The Directors recommend the adoption of the resolution as set out in the Notice.




- 1) Since the company has no fixed assets as on date therefore, the Provisions of clause 4 (i) of the Order are not applicable to the Company.

Significant Accounting policies and Notes on Accounts

A) Significant Accounting Policies

1. General :

- a) The financial statements have been prepared under the historical cost convention in accordance with the generally accepted accounting principles in India and the Accounting Standards issued by the Institute of Chartered Accountants of India and the relevant provision of the Companies Act, 1956 as adopted consistently by the Company.
- b) Accounting policies not specifically referred to are in consonance with the generally accepted accounting principles followed by the Company.
- c) Revenue and Expenses are being accounted for on Mercantile Basis.

2. Basis of Accounting :

All the Income and Expenditures are recognized on Accrual Basis except Rates & Taxes that is accounted for on Cash Basis.

3. Investments :

Investments being long terms and non trade investment are valued at cost and provisions for diminution, if any other than temporary is made to recognize decline in the value of investments on the basis of market/break up value as applicable.

B) Notes on Accounts :

1. Amalgamation of Simon Vanijya Pvt. Ltd and Swagath Vanijya Pvt. Ltd with the Company.
 - a) Pursuant to the scheme of Amalgamation erstwhile Simon Vanijya Pvt. Ltd and Swagath Vanijya Pvt. Ltd with the Company, w.e.f. 1st April, 2010 as approved by the Hon'ble High Court of Kolkata vide order dated 11th day of July, 2011. In terms of the said scheme all the Assets & Liabilities of the erstwhile Transferor Companies were transferred to and vested in the Company w.e.f 1st April, 2010 at their respective book value. The effect for the same have been given in these Accounts accordingly and in consonance with Accounting Policies followed by the Transferee Company.

- b) All the Assets & Liabilities of Transferor Companies have been recorded in these accounts at their respective book values. Excess of Assets taken over and above the Liabilities and Share Capital issued to the shareholders of erstwhile transferor companies has been credited to Securities Premium Account in terms of Scheme as approved by the Hon' able High court of Kolkata.
- c) Pursuant to scheme as referred to in (a) above 10,51,400 Equity Shares of Rs. 10/- is to be issued to the shareholders of erstwhile Simon Vanijya Pvt. Ltd and Swagath Vanijya Pvt. Ltd, Pending Allotment for the same has been credited to Share Capital Suspense Account
- d) As per order of Hon'ble High Court, Kolkata dated 11.07.2011 the Authorized Share Capital of Transferor Companies have been amalgamated with the company and increased from Rs.150 lacs to Rs.184 lacs.
- e) 173,400 Equity Shares of Rs. 10/- each were cancelled in respect to Scheme of Amalgamation as read in 1 (a) above.
2. During the year the company has transferred Rs.2,654.68/- (P.Y.Rs.1160/-) to Special Reserve Account in accordance with 45IC of RBI Act, 1934.
3. During the year the company has made a provision of Rs.38,481.59/- on Standard Assets as per NBFC Prudential Norms under notification number DNBS.222 CGM(US)2011 and DNBS.223 CGM(US)2011 dated January,17,2011
4. The company having Deferred Tax Assets due to carry forward losses as per AS-22, the same has not been recognized in the accounts as a matter of prudence.
5. In the opinion of the Board the Current Assets, Loans & Advances have realization value in the ordinary course of business at least equal to which they are stated in Balance Sheet.
6. The Outstanding balance of Sundry Creditors, Deposits and Advances are subject to confirmation and reconciliation, if any.
7. The company has no related party transaction during the year.
8. The company has only one segment i.e. Finance and Investment Activities hence no segment reporting is given as required under AS-17 issued by ICAI.




